**A BILL**

Making emergency supplemental appropriations for the fiscal  
year ending September 30, 2014, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       That the following sums are appropriated, out of any  
4       money in the Treasury not otherwise appropriated, for the  
5       fiscal year ending September 30, 2014, and for other pur-  
6       poses, namely:

1 TITLE I  
2 SOUTHWESTERN BORDER CRISIS  
3 CHAPTER 1  
4 DEPARTMENT OF JUSTICE  
5 GENERAL ADMINISTRATION  
6 ADMINISTRATIVE REVIEW AND APPEALS

7 For an additional amount for “Administrative Review  
8 and Appeals” to cover necessary expenses to respond to  
9 the significant rise in unaccompanied children and adults  
10 with children at the southwest border and related activi-  
11 ties, \$123,400,000, to remain available until September  
12 30, 2015: *Provided*, That such amount is designated by  
13 the Congress as an emergency requirement pursuant to  
14 section 251(b)(2)(A)(i) of the Balanced Budget and  
15 Emergency Deficit Control Act of 1985: *Provided further*,  
16 That of the amount provided:

17 (1) \$6,700,000 is for the Executive Office of  
18 Immigration Review for courthouse equipment and  
19 automated system requirements;

20 (2) \$5,000,000 is for the Executive Office for  
21 Immigration Review Legal Orientation Program;

22 (3) \$50,000,000 is for the Executive Office for  
23 Immigration Review to implement a program to pro-  
24 vide counsel for unaccompanied alien children; and

1 (4) \$500,000 shall be transferred to the De-  
2 partment of Justice’s Office of Inspector General for  
3 audits and investigations related to the response to  
4 the rise in unaccompanied children and adults with  
5 children at the southwest border.

##### 7 SALARIES AND EXPENSES, GENERAL LEGAL ACTIVITIES

8 For an additional amount for “Salaries and Ex-  
9 penses, General Legal Activities” to cover necessary ex-  
10 penses to respond to the significant rise in unaccompanied  
11 children and adults with children at the southwest border  
12 and related activities, \$1,100,000, to remain available  
13 until September 30, 2015: *Provided*, That such amount  
14 is designated by the Congress as an emergency require-  
15 ment pursuant to section 251(b)(2)(A)(i) of the Balanced  
16 Budget and Emergency Deficit Control Act of 1985.

#### 17 CHAPTER 2

##### 18 DEPARTMENT OF HOMELAND SECURITY

##### 19 OFFICE OF INSPECTOR GENERAL

20 For an additional amount for the “Office of Inspector  
21 General” to cover necessary expenses, including additional  
22 investigations, screenings, and detention facility site visits,  
23 to respond to the significant rise in unaccompanied chil-  
24 dren and adults with children at the southwest border,  
25 \$1,000,000, to remain available until September 30, 2015:

1 *Provided*, That such amount is designated by the Congress  
2 as an emergency requirement pursuant to section  
3 251(b)(2)(A)(i) of the Balanced Budget and Emergency  
4 Deficit Control Act of 1985.

5 U.S. CUSTOMS AND BORDER PROTECTION

6 SALARIES AND EXPENSES

7 For an additional amount for “Salaries and Ex-  
8 penses” to cover necessary expenses to respond to the sig-  
9 nificant rise in unaccompanied children and adults with  
10 children at the southwest border and related activities, in-  
11 cluding the acquisition, construction, improvement, repair,  
12 and management of facilities, and for necessary expenses  
13 related to border security, \$320,549,000, to remain avail-  
14 able until September 30, 2015: *Provided*, That such  
15 amount is designated by the Congress as an emergency  
16 requirement pursuant to section 251(b)(2)(A)(i) of the  
17 Balanced Budget and Emergency Deficit Control Act of  
18 1985.

19 AIR AND MARINE OPERATIONS

20 For an additional amount for “Air and Marine Oper-  
21 ations” to cover necessary expenses to respond to the sig-  
22 nificant rise in unaccompanied children and adults with  
23 children at the southwest border and related activities,  
24 \$22,111,000, to remain available until September 30,  
25 2015: *Provided*, That such amount is designated by the

1 Congress as an emergency requirement pursuant to sec-  
2 tion 251(b)(2)(A)(i) of the Balanced Budget and Emer-  
3 gency Deficit Control Act of 1985.

4 U.S. IMMIGRATION AND CUSTOMS ENFORCEMENT  
5 SALARIES AND EXPENSES

6 For an additional amount for “Salaries and Ex-  
7 penses” to cover necessary expenses to respond to the sig-  
8 nificant rise in unaccompanied children and adults with  
9 children at the southwest border and related activities, and  
10 for the necessary expenses for enforcement of immigration  
11 and customs law, detention and removals of adults with  
12 children crossing the border unlawfully, and investiga-  
13 tions, \$762,795,000, to remain available until September  
14 30, 2015: *Provided*, That such amount is designated by  
15 the Congress as an emergency requirement pursuant to  
16 section 251(b)(2)(A)(i) of the Balanced Budget and  
17 Emergency Deficit Control Act of 1985.

18 GENERAL PROVISION—THIS CHAPTER

19 SEC. 1201. Any appropriations provided to the De-  
20 partment of Homeland Security by this title may be repro-  
21 grammed or transferred without limitation between such  
22 appropriations after notification to the Committees on Ap-  
23 propriations of the Senate and the House of Representa-  
24 tives: *Provided*, That prior to the obligation of such funds,

1 a request shall be submitted to such Committees 15 days  
 2 in advance of such reprogramming or transfer.

3 CHAPTER 3

4 DEPARTMENT OF HEALTH AND HUMAN  
 5 SERVICES

6 ADMINISTRATION FOR CHILDREN AND FAMILIES

7 REFUGEE AND ENTRANT ASSISTANCE

8 (INCLUDING TRANSFER OF FUNDS)

9 For an additional amount for “Refugee and Entrant  
 10 Assistance”, \$1,200,000,000, to be merged with and avail-  
 11 able for the same period and purposes as funds appro-  
 12 priated in Public Law 113–76 “for carrying out such sec-  
 13 tions 414, 501, 462, and 235”: *Provided*, That funds ap-  
 14 propriated under this heading may also be used for other  
 15 medical response expenses of the Department of Health  
 16 and Human Services in assisting individuals identified  
 17 under subsection (b) of section 235 of the William Wilber-  
 18 force Trafficking Victims Protection Reauthorization Act  
 19 of 2008 and for acquisition, construction, improvement,  
 20 repair, operation, and maintenance of real property and  
 21 facilities: *Provided further*, That, the Secretary may, in  
 22 this fiscal year and hereafter, accept and use money,  
 23 funds, property, and services of any kind made available  
 24 by gift, devise, bequest, grant, or other donation for car-  
 25 rying out such sections: *Provided further*, That funds ap-

1 appropriated under this heading for medical response ex-  
2 penses may be transferred to and merged with the “Public  
3 Health and Social Services Emergency Fund”: *Provided*  
4 *further*, That such transfer authority is subject to the reg-  
5 ular notification procedures of the Committees on Appro-  
6 priations: *Provided further*, That not less than \$1,000,000  
7 shall be transferred to the Department of Health and  
8 Human Services “Office of Inspector General” to perform  
9 oversight, accountability, and evaluation of programs,  
10 projects, or activities supported with the funds provided  
11 for the purposes provided herein: *Provided further*, That  
12 the Secretary shall take such action as necessary to ensure  
13 that social services, preventive health, and targeted assist-  
14 ance activities under section 414 of the Immigration and  
15 Nationality Act and section 501 of the Refugee Education  
16 Assistance Act of 1980 are funded in fiscal year 2014 at  
17 levels as prescribed in the detailed table in division H of  
18 the explanatory statement accompanying Public Law 113–  
19 76: *Provided further*, That such amount is designated by  
20 the Congress as an emergency requirement pursuant to  
21 section 251(b)(2)(A)(i) of the Balanced Budget and  
22 Emergency Deficit Control Act of 1985.

2                                   DEPARTMENT OF STATE  
3                                   ADMINISTRATION OF FOREIGN AFFAIRS  
4                                   DIPLOMATIC AND CONSULAR PROGRAMS

5           For an additional amount for “Diplomatic and Con-  
6 sular Programs”, \$2,000,000, to remain available until  
7 September 30, 2015, which may be made available for  
8 public diplomacy and public affairs programs related to  
9 Central American migration issues: *Provided*, That such  
10 amount is designated by the Congress as an emergency  
11 requirement pursuant to section 251(b)(2)(A)(i) of the  
12 Balanced Budget and Emergency Deficit Control Act of  
13 1985.

14                                   RELATED AGENCY  
15                                   BROADCASTING BOARD OF GOVERNORS  
16                                   INTERNATIONAL BROADCASTING OPERATIONS

17           For an additional amount for “International Broad-  
18 casting Operations”, \$500,000, to remain available until  
19 September 30, 2015, which may be made available only  
20 for public service announcements and other broadcasts re-  
21 lated to Central American migration issues: *Provided*,  
22 That such amount is designated by the Congress as an  
23 emergency requirement pursuant to section  
24 251(b)(2)(A)(i) of the Balanced Budget and Emergency  
25 Deficit Control Act of 1985.



1           BILATERAL ECONOMIC ASSISTANCE  
2           FUNDS APPROPRIATED TO THE PRESIDENT  
3                   ECONOMIC SUPPORT FUND  
4                   (INCLUDING TRANSFER OF FUNDS)

5           For an additional amount for “Economic Support  
6 Fund”, \$212,500,000, to remain available until Sep-  
7 tember 30, 2015, for necessary expenses to implement the  
8 strategy required in section 1401 of this chapter to ad-  
9 dress the root causes of migration from Central America,  
10 including to support the safe repatriation and reintegra-  
11 tion of migrants: *Provided*, That funds appropriated under  
12 this heading in this Act may be transferred to, and merged  
13 with, funds made available under the heading “Complex  
14 Crises Fund” in title III of acts making appropriations  
15 for the Department of State, foreign operations, and re-  
16 lated programs, and may be further transferred under ex-  
17 isting relevant authorities: *Provided further*, That funds  
18 transferred pursuant to the previous proviso shall remain  
19 available until September 30, 2015: *Provided further*, That  
20 of the funds appropriated under this heading in this Act,  
21 \$5,000,000 shall be transferred to the Inter-American  
22 Foundation for in-country training and other programs  
23 for at-risk youth in Central America: *Provided further*,  
24 That of the funds appropriated under this heading in this  
25 Act, \$10,000,000 shall be transferred to the Department

1 of Justice to support programs to build investigative and  
2 prosecutorial capacity in the justice systems of Guatemala,  
3 Honduras, and El Salvador: *Provided further*, That such  
4 amount is designated by the Congress as an emergency  
5 requirement pursuant to section 251(b)(2)(A)(i) of the  
6 Balanced Budget and Emergency Deficit Control Act of  
7 1985.

8 INTERNATIONAL SECURITY ASSISTANCE

9 DEPARTMENT OF STATE

10 INTERNATIONAL NARCOTICS CONTROL AND LAW

11 ENFORCEMENT

12 For an additional amount for “International Nar-  
13 cotics Control and Law Enforcement”, \$85,000,000, to re-  
14 main available until September 30, 2015, for necessary ex-  
15 penses to implement the strategy required in section 1401  
16 of this chapter to address the root causes of migration  
17 from Central America, including to strengthen law en-  
18 forcement and judicial system capacity: *Provided*, That  
19 such amount is designated by the Congress as an emer-  
20 gency requirement pursuant to section 251(b)(2)(A)(i) of  
21 the Balanced Budget and Emergency Deficit Control Act  
22 of 1985.

1           GENERAL PROVISIONS—THIS CHAPTER  
2                   (INCLUDING TRANSFER OF FUNDS)

3   MULTI-YEAR PREVENTION AND RESPONSE STRATEGY

4       SEC. 1401. Not later than 90 days after enactment  
5 of this Act and prior to the obligation of funds appro-  
6 priated under this chapter in this Act, the Secretary of  
7 State and the Administrator of the United States Agency  
8 for International Development (USAID), following con-  
9 sultation with the heads of other relevant United States  
10 Government agencies, the Committees on Appropriations  
11 and the Committee on Foreign Relations of the Senate  
12 and the Committee on Foreign Affairs of the House of  
13 Representatives, civil society organizations, and national  
14 and local governments in Central America, shall jointly  
15 submit to such committees an integrated, multi-year pre-  
16 vention and response strategy to inform Central American  
17 children and their families of the dangers of the journey  
18 to the United States and to address the root causes of  
19 migration from Central America, including: to strengthen  
20 social services, law enforcement, and judicial system ca-  
21 pacity (with an emphasis on community policing and other  
22 community violence reduction programs) to dismantle  
23 criminal gangs, combat other organized crime and violence  
24 (including domestic and sexual abuse), extortion, narcotics  
25 trafficking, and human smuggling and trafficking; elimi-

1 nate public sector corruption and strengthen governance;  
2 develop child welfare services (including shelters); provide  
3 safe educational, vocational, and technical training oppor-  
4 tunities for children and youth; address obstacles to equi-  
5 table economic growth and support job creation programs;  
6 expand the activities of the United Nations High Commis-  
7 sioner for Refugees in Central America; and to support  
8 the safe repatriation and reintegration of migrants: *Pro-*  
9 *vided*, That the Secretary of State and the USAID Admin-  
10 istrator shall implement such strategy through civil society  
11 organizations to the maximum extent practicable: *Pro-*  
12 *vided further*, That such strategy shall also include pro-  
13 jected annual funding requirements, specific goals, and  
14 benchmarks for measuring progress: *Provided further*,  
15 That the Secretary of State shall designate a senior offi-  
16 cial to oversee coordination and implementation of the  
17 strategy: *Provided further*, That the Secretary of State  
18 should suspend assistance for a central government in  
19 Central America made available by this Act and prior acts  
20 making appropriations for the Department of State, for-  
21 eign operations, and related programs if the Secretary, in  
22 consultation with the USAID Administrator, as appro-  
23 priate, determines that such government is not cooper-  
24 ating in meeting such goals and benchmarks.

## 1 COST-MATCHING REQUIREMENT

2 SEC. 1402. Funds appropriated by this Act and prior  
3 acts making appropriations for the Department of State,  
4 foreign operations, and related programs under the head-  
5 ings “Economic Support Fund” and “International Nar-  
6 cotics Control and Law Enforcement” that are made avail-  
7 able to address the root causes of migration from Central  
8 America, and to support the safe repatriation and re-  
9 integration of migrants, shall be made available, to the  
10 maximum extent practicable, on a cost-matching basis:  
11 *Provided*, That the Secretary of State shall inform the  
12 Committees on Appropriations on efforts to implement the  
13 requirement of this section.

## 14 CONSULTATION AND NOTIFICATION

15 SEC. 1403. Funds appropriated under this chapter  
16 in this Act may only be made available for obligation and  
17 transfer following consultation with the Committees on  
18 Appropriations and the Committee on Foreign Relations  
19 of the Senate and the Committee on Foreign Affairs of  
20 the House of Representatives, and such funds and funds  
21 appropriated in prior Acts making appropriations for the  
22 Department of State, foreign operations, and related pro-  
23 grams to address the root causes of migration from Cen-  
24 tral America, and to support the safe repatriation and re-  
25 integration of migrants, shall be subject to the regular no-

1 tification procedures of the Committees on Appropria-  
2 tions.

3 OVERSIGHT

4 SEC. 1404. Of the funds appropriated by this Act  
5 under the headings “Diplomatic and Consular Programs”,  
6 “Economic Support Fund”, and “International Narcotics  
7 Control and Law Enforcement”, not less than \$500,000  
8 shall be transferred to, and merged with, funds appro-  
9 priated under the heading “Department of State and Re-  
10 lated Agency, Administration of Foreign Affairs, Office of  
11 Inspector General”, and not less than \$1,000,000 shall be  
12 transferred to, and merged with, funds appropriated under  
13 the heading “United States Agency for International De-  
14 velopment, Funds Appropriated to the President, Office  
15 of Inspector General” for the purpose of oversight of funds  
16 appropriated under this chapter in this Act: *Provided*,  
17 That funds transferred pursuant to this section shall re-  
18 main available until September 30, 2015.

19 CHAPTER 5

20 GENERAL PROVISIONS—THIS TITLE

21 SEC. 1501. Not to exceed \$250,000,000 of any ap-  
22 propriation made available in this title may be transferred  
23 between such appropriations with the approval of the Di-  
24 rector of the Office of Management and Budget: *Provided*,  
25 That the Committees on Appropriations of the Senate and

1 the House of Representatives are notified 15 days in ad-  
2 vance of any such transfer by the Director of the Office  
3 of Management and Budget: *Provided further*, That such  
4 transfer authority is in addition to any other transfer au-  
5 thority provided by this or any other Act.

6       SEC. 1502. The Secretary of Homeland Security, in  
7 consultation with the Secretary of State and the Attorney  
8 General, shall submit to the Committees on Appropria-  
9 tions of the Senate and the House of Representatives a  
10 plan on the steps the United States Government will take  
11 to interdict and disrupt human smuggling, trafficking or-  
12 ganizations and other transnational criminal organizations  
13 transporting unaccompanied children and adults with chil-  
14 dren to the southwest border of the United States: *Pro-*  
15 *vided*, That such plan shall include, but not be limited to,  
16 investigations into smuggling and trafficking methods, de-  
17 tailed resource and staffing requirements at each Depart-  
18 ment to combat these organizations, and how existing as-  
19 sets will be deployed to secure the border: *Provided fur-*  
20 *ther*, That such plan shall be submitted within 45 days  
21 from enactment of this Act with quarterly updates there-  
22 after until September 30, 2015.

1 TITLE II  
2 WILDLAND FIRE MANAGEMENT  
3 DEPARTMENT OF AGRICULTURE  
4 FOREST SERVICE  
5 WILDLAND FIRE MANAGEMENT

6 For an additional amount for “Wildland Fire Man-  
7 agement” to cover necessary expenses for wildfire suppres-  
8 sion and emergency rehabilitation activities of the Forest  
9 Service, \$615,000,000, to remain available until expended:  
10 *Provided*, That such funds shall only become available if  
11 funds previously provided for wildland fire suppression will  
12 be exhausted imminently and the Secretary of Agriculture  
13 notifies the Committees on Appropriations of the House  
14 of Representatives and the Senate in writing of the need  
15 for these additional funds: *Provided further*, That such  
16 amount is designated by the Congress as an emergency  
17 requirement pursuant to section 251(b)(2)(A)(i) of the  
18 Balanced Budget and Emergency Deficit Control Act of  
19 1985.

20 GENERAL PROVISIONS—THIS TITLE  
21 WILDFIRE DISASTER FUNDING AUTHORITY

22 SEC. 2101. (a) IN GENERAL.—Section 251(b)(2) of  
23 the Balanced Budget and Emergency Deficit Control Act  
24 of 1985 (2 U.S.C. 901(b)(2)) is amended by adding at  
25 the end the following:



1 “(E) FLAME WILDFIRE SUPPRESSION.—

2 “(i) If a bill or joint resolution mak-  
3 ing appropriations for a fiscal year is en-  
4 acted that specifies an amount for wildfire  
5 suppression operations in the Wildland  
6 Fire Management accounts at the Depart-  
7 ment of Agriculture or the Department of  
8 the Interior, then the adjustments for that  
9 fiscal year shall be the amount of addi-  
10 tional new budget authority provided in  
11 that Act for wildfire suppression operations  
12 for that fiscal year, but shall not exceed—

13 “(I) for fiscal year 2015,  
14 \$1,410,000,000 in additional new  
15 budget authority;

16 “(II) for fiscal year 2016,  
17 \$1,460,000,000 in additional new  
18 budget authority;

19 “(III) for fiscal year 2017,  
20 \$1,557,000,000 in additional new  
21 budget authority;

22 “(IV) for fiscal year 2018,  
23 \$1,778,000,000 in additional new  
24 budget authority;

1           “(V) for fiscal year 2019,  
2           \$2,030,000,000 in additional new  
3           budget authority;

4           “(VI) for fiscal year 2020,  
5           \$2,319,000,000 in additional new  
6           budget authority; and

7           “(VII) for fiscal year 2021,  
8           \$2,650,000,000 in additional new  
9           budget authority.

10          “(ii) As used in this subparagraph—

11               “(I) the term ‘additional new  
12               budget authority’ means the amount  
13               provided for a fiscal year, in excess of  
14               70 percent of the average costs for  
15               wildfire suppression operations over  
16               the previous 10 years, in an appro-  
17               priation Act and specified to pay for  
18               the costs of wildfire suppression oper-  
19               ations; and

20               “(II) the term ‘wildfire suppres-  
21               sion operations’ means the emergency  
22               and unpredictable aspects of wildland  
23               firefighting including support, re-  
24               sponse, and emergency stabilization  
25               activities; other emergency manage-

1                   ment activities; and funds necessary  
2                   to repay any transfers needed for  
3                   these costs.

4                   “(iii) The average costs for wildfire  
5                   suppression operations over the previous  
6                   10 years shall be calculated annually and  
7                   reported in the President’s Budget submis-  
8                   sion under section 1105(a) of title 31,  
9                   United States Code, for each fiscal year.”.

10           (b) DISASTER FUNDING.—Section 251(b)(2)(D) of  
11 the Balanced Budget and Emergency Deficit Control Act  
12 of 1985 (2 U.S.C. 901(b)(2)(D)) is amended—

13                   (1) in clause (i)—

14                           (A) in subclause (I), by striking “and” and  
15                           inserting “plus”;

16                           (B) in subclause (II), by striking the pe-  
17                           riod and inserting “; less”; and

18                           (C) by adding the following:

19                                   “(III) the additional new budget  
20                                   authority provided in an appropriation  
21                                   Act for wildfire suppression operations  
22                                   pursuant to subparagraph (E) for the  
23                                   preceding fiscal year.”; and

24                   (2) by adding at the end the following:

1           “(v) Beginning in fiscal year 2017  
2           and in subsequent fiscal years, the calcula-  
3           tion of the ‘average funding provided for  
4           disaster relief over the previous 10 years’  
5           shall include for each year within that av-  
6           erage the additional new budget authority  
7           provided in an appropriation Act for wild-  
8           fire suppression operations pursuant to  
9           subparagraph (E) for the preceding fiscal  
10          year.”.

11                               REPORTING REQUIREMENTS

12          SEC. 2102. (a) SUPPLEMENTAL APPROPRIATIONS.—

13          If the Secretary of the Interior or the Secretary of Agri-  
14          culture determines that supplemental appropriations are  
15          necessary for a fiscal year for wildfire suppression oper-  
16          ations, the Secretary of the Interior or the Secretary of  
17          Agriculture, as applicable, shall promptly submit to Con-  
18          gress estimates for such supplemental requirements.

19          (b) ACCOUNTING, REPORTS AND ACCOUNT-  
20          ABILITY.—

21                       (1) ACCOUNTING AND REPORTING REQUIRE-  
22          MENTS.—In each fiscal year, the Secretary of the  
23          Interior and the Secretary of Agriculture shall ac-  
24          count for and report on the amounts used from the  
25          additional new budget authority for wildfire suppres-

1 sion operations provided to the Secretary of the In-  
2 terior or the Secretary of Agriculture, as applicable,  
3 in an appropriations Act pursuant to subparagraph  
4 (E)(ii) of section 251(b)(2) of the Balanced Budget  
5 and Emergency Deficit Control Act of 1985 (2  
6 U.S.C. 901(b)(2)) (as amended by section 2101(b)  
7 of this Act).

8 (2) ANNUAL REPORT.—

9 (A) IN GENERAL.—Not later than 180  
10 days after the end of each fiscal year for which  
11 additional new budget authority is used pursu-  
12 ant to subparagraph (E)(ii) of section  
13 251(b)(2) of the Balanced Budget and Emer-  
14 gency Deficit Control Act of 1985 (2 U.S.C.  
15 901(b)(2)) (as amended by section 2101(b) of  
16 this Act), the Secretary of the Interior or the  
17 Secretary of Agriculture, as applicable, shall—

18 (i) prepare an annual report with re-  
19 spect to the additional new budget author-  
20 ity;

21 (ii) submit to the appropriate commit-  
22 tees of Congress the annual report pre-  
23 pared under clause (i); and
